## — Consignment Agreement Policy —

1. All items are consigned for 90 days.
2. Each consigned item must have a minimum original selling price of \$100.00.
3. The Consignor will receive 50% of the selling price.
4. The Liberty Youth Ranch Upscale Shop (LYRUS) reserves the right to reduce the price of any item during the 90-day consignment period by up to 15% of the original price without prior notification to the Consignor.
5. The Consignor is responsible for any costs associated with pick-up of the item(s). Pick-up fees must be paid prior to the scheduled pick-up date and are non-refundable. LYRUS accepts new and like-new condition items only. Items deemed unacceptable due to rips, tears, stains, fading, odors, pet hair, water damage, breakage, or other condition issues will not be accepted at pick-up.
6. All items are priced by the LYRUS acquisition appraiser based on current market value and comparable resale pricing.
7. Consignors have secure online access to their account through the Liberty Consignor Center, which provides real-time information including consigned inventory, pricing, sales, payable balances, and expiration dates. Consignors are responsible for reviewing and monitoring their account and tracking items.
8. Payment for sold items will be issued by check during the month following the sale. Checks will be available after the 10th of that month. Checks must be claimed and deposited within ninety (90) days of issuance. Checks will not be reissued for any reason. Any payment that remains **unclaimed or uncashed after ninety (90) days** will be considered **voluntarily donated to Liberty Youth Ranch**.
9. The Consignor must notify LYRUS one week prior to the 90-day expiration date if they wish to pick up unsold item(s). If no notification is received and/or the item(s) are not picked up by the expiration date, the item(s) will **automatically become the property of LYRUS and will be treated as a donation**. LYRUS is not responsible for payment of items sold after the expiration date.
10. LYRUS is not liable for loss or damage to items due to fire, theft, accident, or natural disaster.
11. It is the Consignor's responsibility to retain a copy of this agreement.
12. This agreement is in effect in its entirety for all current and subsequent consigned item(s).
